A Letter from the Principal

Newness, growth, and hope described the 2009-10 school year at Mother Seton Academy. Throughout our first year in our new home, we offered a solid education in and out of the classroom. Additionally, the entire Mother Seton Academy family—students, families, staff, and volunteers—collaborated to establish meaningful new programs for our school while maintaining MSA traditions.

In the classroom, teachers motivated learning by tapping into their creativity. Eighth grade religion classes featured a guest speaker who worked with students to set and achieve goals. In social studies, students learned about current events through hip-hop music. A team of teachers developed cross-curricular lessons focused on the Winter Olympics.

Under the leadership of Sr. Lisa Perkowski, IHM, the arts blossomed. A cadre of volunteer music teachers taught piano, voice, guitar, clarinet, and harp lessons to our students. In music classes, students learned to read music and play the recorder and piano. The Sunrise Art Club, which met before school, worked for months to produce a magnificent mosaic cross filled with colorful ceramic tiles. Their

masterpiece is now installed in our Prayer Room.

The After-school Club Program expanded as well. Ten students, with varying swimming ability, participated in the Swim Club. The group travelled weekly to Loyola University Maryland for swim instruction. For some, this was their first experience in the pool; for others with basic swim skills, the lessons allowed them to become stronger swimmers.

Our faithful parents and guardians worked with Br. Jesse O'Neill, SM, to develop a new tradition of Family Nights at MSA. Parent volunteers set up the school and prepared meals, while the large screen in our multipurpose room transformed the school into a family-friendly movie theater. Attendance at every Family Night topped one hundred guests.

Thank you to everyone whose talents and generosity made our first year on Greenmount Avenue the success it was; we are grateful for your support.
